Offense Information of SR Inmates Serving Mandatory Minimum Sentences

As of June 30, 2019, there were 34,719 inmates in the State Responsible (SR) Confined Population¹. Of those, 94% were serving a regular, calculated sentence (n=32,537) while the remaining 6% were serving one or more life sentences (n=2,145), death sentence (n=3), or three strikes sentence (n=34). Among the 32,537 SR inmates serving a calculated sentence, more than one-third (34%) had been sentenced for an offense that carries a mandatory minimum sentence of incarceration.

More than one-half (56%) of the 21,547 SR inmates incarcerated for only offenses that do not have mandatory minimum sentences had a Violent Most Serious Offense (MSO), while 28% had a Property/Public Order MSO and 15% had a Drug MSO. The most prevalent MSOs for these inmates were: Larceny/Fraud (17%); Rape/Sexual Assault (15%); Robbery (12%); and Assault (11%).

The 21,547 SR inmates incarcerated for *only* offenses that do *not* have mandatory minimum sentences had been sentenced for 229,829 offenses², of which, the ten most prevalent offenses accounted for 29%. These top ten offenses were led by LAR-2359-F9 (Grand Larceny: >=\$200 Not from a Person)³ at 6.7% and NAR-3022-F5 (Possession of Schedule I/II Drugs) at 4.2%.

More than two-thirds (67%) of the 9,491 SR inmates incarcerated for **both** offenses that have mandatory minimum sentences and offenses that do not have mandatory minimum sentences had a Violent Most Serious Offense (MSO), while 15% had a Property/Public Order MSO and 19% had a Drug MSO. The most prevalent MSOs for these inmates were: Robbery (25%); Assault (17%); Drug Sales (14%).

² Please note that any offense code beginning with "NCIC" are for sentencing records that pre-date VADOC's ability to record VCC information with the implementation of the sentencing module in VirginiaCORIS in 2006; NCIC offense codes were often more generalized than VCC offense codes and there was not a one-for-one match of VCC to NCIC.

offenses accounted for 27%. The top ten offenses were led by: ASL-1319-F9 (Firearm: Use In Commission Of Felony, 1st Offense) at 6.4%; LAR-2359-F9 (Grand Larceny: >=\$200 Not from a Person) at 3.9%; and NAR-3022-F5 (Possession of Schedule I/II Drugs) at 3.7%.

One-half (50%) of the 1,499 SR inmates incarcerated for only offenses that have mandatory minimum sentences had a Violent Most Serious Offense (MSO), while 17% had a Property/Public Order MSO and 32% had a Drug MSO. The most prevalent MSOs for these inmates were: Weapons (31%); Drug Sales (31%); and DUI (12%).

The 1,499 SR inmates incarcerated for only offenses that have mandatory minimum sentences had been sentenced for 4,001 offenses, of which, the ten most prevalent offenses accounted for 35%. The top ten offenses were led by: NAR-3038-F9 (Manufacture/Distribute Schedule I/II Drugs, 2nd Offense) at 12.2%; LIC-6834-F9 (License Revoked: Habitual Offender Drive without License, 2nd or subsequent Offense) at 9.6%; and WPN-5297-F6 (Firearm: Possession by Nonviolent Felon within 10 years) at 7.4%.
